Baseball Sask Umpire Executive Committee Meeting Minutes

Date: March 30, 2021, 2020 – Via Zoom

I. Call to order

Scott Mills Provincial Supervisor called to order to meeting at 19:06 on March 30, 2021 via Conference Call.

II. Roll call

III. Business

- i) Registration:
 - (1) Level 1 through 5 RAMP registration is ready to go. Have had some frustrations with RAMP, but as of the meeting it is ready to go. Benefits creation of

database and long-term registry. Goal is long term expansion to use and distribute Sask Umpire related content

- (a) Roberts tasked with sending out information to clinic contacts
- (b) McGee tasked with social media
- (c) Mills with discuss with Ramage to upload links etc on Baseball Sask umpire page.

ii) Level 3

- Mills proposed a review of the operations manuals. Reason as it was felt that some criteria created a potential to back the organization into a corner. This has been evident during COVID.

Prior to the meeting it read as such:

Advancing to the Level 4 (National) Program

Fully certified level 3 umpires who wish to advance to level 4 must meet the following requirements: 1) Successfully completed at least 1 full 3-year cycle in the level 3 program.

- 2) Achieve a passing mark on the current level 3 exam
- 3) A successful on field evaluation in the current year.
- 4) Apply, and receive approval from the high performance committee. This application must be submitted by March 31st.

Proposal to read – changes highlighted in bold:

Fully certified level 3 umpires who wish to advance to level 4 must meet the following requirements: 1) It is recommended that a Level 3 umpire complete at least 1 full 3-year cycle in the Level 3 program, but they are eligible to apply for the Level 4 program after 1 full year as a Level 3 and have completed steps 2 through 5 below.

- 2) Successfully complete the previous year's Level 3 requirements (Exam, Online E-Learning or Level 3 clinic).
- 3) Successfully complete and pass the Level 3 exam before applying for Level 4. Umpires may write/rewrite the level 3 exam in a non-exam year in addition to the learning requirements for level 3 in that year. Level 3 umpires will only be able to attempt the exam once per year. 4) A successful on field evaluation in the current year. (Plate and Base)
- **5)** Apply, and receive approval from the High Performance Committee. This application must be submitted by March 31st.

Discussion had regarding changes to level 3 criteria:

Elemer – concerns with wording over accept/approve application.

Mills – all application will be accepted, not all applications will necessarily be approved for advancement.

McGee – request to remove requirements in brackets for level 3, reason: in the events the requirements change, then less changes to manual.

Level 3 Exam:

Mills – If an umpire fails, then they are eligible next year to rewrite the exam.

Drury – if they fail 3 years in a row, they are demoted to adult safe baseball

Return to Play:

Baseball Sask still working on it, no official changes at this time

Looking similar to last year, but don't be surprised if changes – re: Mandatory Masking if cant physical distance

Nationals:

No official word at this time, can expect an announcement March 31/April 1. Baseball Canada will be releasing info soon.

Female development:

Mills received a call from Lisa Turbitt who has been asked by Andre Lachance to look at building female umpire specific program. It is difficult for us with our current registration system, hopefully RAMP will help with early identification and we can build on it from there. Lisa is hoping to have an early May virtual roundtable with female officials in the province.

Umpire Annual General Meeting Minutes 10:00 AM, October 24th, 2020 Via Zoom Call

1. Call to Order – 10:34am

2. Roll Call

6. Business Arising from Minutes

a. Zone Reports

It was presented that there is a need for consistent zone reports. For that reason Trevor, Aaron and Joe will work together to create a Zone Report Template for future Zone Directors to follow when submitting annual zone reports to the provincial executive.

b. Baseball Sask Uniforms

Executive discussed continuing with the current uniforms and supplies. We must consider that the Baseball Sask Logo is not our property, therefore we must always use Al Anderson's Source for Sports for the logo/stitching. Adults are finding the jerseys not suitable for officiating, nor are they 'good' quality, whereas the jerseys are durable and good quality for youth officials. Phil suggests the idea of having a specific adult jersey that is higher quality that senior umpires could be directed to use and get the logo put on by Al Anderson's. Economics is a challenge: affordability vs. practicality for age groups, development level and level of ball worked.

Consensus was that umpires should purchase a Baseball Sask Logo Hat. That way, for provincial play, umpires can use the Baseball Sask Jersey if they feel comfortable in it, if not umpires are encouraged to purchase and wear a Baseball Canada Logo jersey. During the season, at least umpires have the Baseball Sask logo hat.

7. Committee Reports

a. Supervisor

Scott Mills reviewed the Supervisor's Report with executive. Highlights include:

 Many sports are asking how Baseball Sask is retaining umpires; our program direction seems to be improving in this area and other sports associations are seeking guidance from Baseball Sask.

- Late Registrations have been a large challenge for directors to record, especially this year with COVID-19 delays. Baseball Sask provincial executive, too, have mentioned the challenges with documenting registrations. Scott Mills and executive will be working with Baseball Canada to hopefully streamline registration, thus help simplify the process. Many other sports do their official registration and fees online; we will be looking into platforms but need to align our plans with Baseball Canada's.
- Throughout the season, there was not a single case of COVID-19 reported linked to participating in baseball.
- Thanks to Brad Biermann and all organizers involved in this year's Sask-Alta Super Clinic. The style of the clinic was extremely well received. Scott plans to communicate with Alberta Executive to create a similar Super Clinic in the future. Many attendees gave positive feedback about having MLB/Minor League Officials, Bullpen Session and facilities. This was our best received Super Clinic in recent years.
- National Assignments: We are hopeful for 2021 Nationals to move forward. Regina will likely be hosting the Baseball Canada Cup; please consider volunteering or supporting umpires during the championship week. Assignments for next season may not include all of the assigned individuals from the 2020 assignment list. There will be many discussions to make sure that selections are with best intentions of development, reward/earned opportunity, and for the best of Baseball Sask Umpire Membership.
- Thank you, Philip for your contributions to the online communications. Baseball Sask Umpires are earning a positive reputation that is being promoted through online platforms.
- Elemer Jerkovits and Rocky Nickel were both inducted this season into the Baseball Saskatchewan Hall of Fame. Congratulations to these gentlemen and thank you for your contributions to the program. Induction ceremony will likely be in May, 2021 for anyone wishing to join.
- Baseball Canada AGM: Trevor Drury received the Dick Willis Umpire of the Year Award and Rocky Nickel received the Baseball Canada Lifetime Achievement Award. Congratulations to these individuals and thank you for your contributions to baseball in Saskatchewan and Canada.
- Discipline: There were many ejections and an increase in suspensions; also considering the reduced amount of games province wide, this is alarming. Game Management will need to be a focus at clinics this coming season. Some of the mismanagement of in-game behaviour, or lack of skill base to do so effectively, is likely due to COVID-19 and no in-person clinics. One umpire received a disciplinary action in the 2020 season. Mills, Huck and the Baseball Sask Commissioners plan to develop an Umpire Disciplinary Committee.
- Scott Mills proposed to Baseball Sask Executive to expand the double header ejection suspension rule. Provinicial Executive will consider making a 1 game suspension in a double header if an ejection occurs in the final inning of play in game 1 or prior to the 2nd game.

b. Past Supervisor

Strongly encouraged that zone reports need to be consistent and meaningful. As mentioned above, a task force was created to take this on. Trevor was shoulder tapped by Baseball Canada to go to an upcoming national championship to review National Supervisor Procedures.

c. Assistant Supervisor

Huck was unable to attend the full meeting and left notes for Scott Mills to share. As submitted.

d. Executive Committee

Education

Thanks to all those who helped with creating online content. Registrations were difficult this year, as mentioned above. Strongly recommends for online payments and registrations to be online. As submitted.

2021 was another challenging year for baseball but not to the extent of last season. We had a noticeable rebound in our umpire registration numbers from 2020 but are still well below 2019 numbers. I have some major concerns in this area that I will address later in this report. With the availability of online clinics that were offered by the British Columbia Baseball Umpire Association (BCBUA), Baseball Ontario and Baseball Canada this year, we were able to offer improved umpire clinic experiences for all of the umpires this year. There were still some issues regarding accessibility, internet bandwidth and lack of computer skills, but overall, the feedback received regarding the clinic experiences was generally positive. I will expand more on the education goals later in this report. Once again we are seeing some declining numbers of officials in rural areas and some of that can be attributed due to apprehension due to Covid-19, some of the uncertainty of when the season was going to start and some communities with uncertainty if they were going to have a season.

A huge step forward in our ability to register and track umpires in Saskatchewan was the development of the RAMP registration system for umpires. Umpires will now be required to register online prior to or just after attending an umpire clinic. There were some minor issues with the new system, but these should get ironed out as umpires get familiar with the process. Many of the issued experienced was due to some individuals lack of computer skills. The RAMP system gave our division the ability to easily communicate with all registered umpires in the province. It also allows us to track and quickly identify the locations and levels of umpires in communities. The Ramp system still needs some modifications so that the registered umpires can be sorted according to Zones. We want to look into expanding the RAMP system to also allow for clinic preregistration for scheduled umpire clinics. Our division would also like to explore expanding our online presence further for educational purposes.

In 2022, zone directors are going to have to take a prominent role in encouraging the communities in their zones to focus on developing umpires with similar dedication that they develop players and coaches and actively recruit umpires back to the program. As expected numbers of officials dropped significantly in 2020 with some rebound in 2021 but there is still a long way to go. Our program had

some great momentum going into 2020 and we want to recapture some of that positive growth we had this year and continue that into 2022. Many of the great baseball people in this province are going to have to put forth some extra time and effort to help rebuild the officials in this province. I do have some major concerns regarding communities that are ignoring the development of umpires in their baseball programs. There are many communities that are using unregistered officials for all levels of baseball and there are some communities with established baseball programs and very few or no registered umpires in their communities. I will be bringing these communities forward to the umpire zone directors so they can help these communities with clinics, etc. and I will be drafting a letter to send out to communities to encourage umpire development and the advantages of using registered officials. I will also be addressing this issue with Baseball Saskatchewan as there currently is no incentive for communities to use registered officials, and until there is enforcement and repercussions for using unregistered officials, many communities will have little interest in umpire development. There were many communities this season that were hosts of provincial championships that had very few or no registered officials, and this must change, even though hosts are often hard to find. We have had requirements in the past that to host a provincial championship, a community had to host an umpire clinic, and with it looking like face to face clinics will resume next year, this once again must become a requirement.

All umpire clinics this year were in online formats. The costs of using the online formats for all levels were excellent which made the decision to use these formats a simple one. All the Level 3, 4 and 5 umpires attended a virtual superclinic that was hosted by BCBUA and Baseball Ontario. Every province in Canada jumped on board with this online clinic and there were several weekends in March and April where the umpires could register and take their virtual clinic which was a combination of live virtual instruction and recorded sessions. There was involvement from Baseball Canada national evaluators and course conductors as well as contributions from MLB umpires Tripp Gibson, Hunter Wendlestadt, Mike Muchlinski and Stu Scheurwater. This was a phenomenal event that all umpires learned a great deal from. This may become a regular clinic every 3 years for all umpires across the country, we will see where it goes. Level 1 and 2 clinics were going to be a challenge until BCBUA approached us to be a part

of their virtual 1 & 2 clinics that were hosted in a format very similar to the level 3/4/5 superclinic. There were some challenges for our umpires due to computer and bandwidth issues but for the most part, the reviews for the clinic material were favorable. It was frustrating as there were many individuals that registered late, some the day after the last virtual clinic so we had to come up with a plan for educational material for these umpires to get registered. We got as many people as we could registered, and with the creation of the RAMP system, it will become easier to communicate with our umpires.

With the success of the virtual clinics this year, and through conversations with officials from other sports, I strongly believe that we need to revamp the level 1 and 2 umpire training in Saskatchewan. The curriculum we have is sound, we just need to look at delivering it a different way. One of the most frequent complaints we receive regarding umpire clinics is that they are too long. In response to this and the improvement in online platforms, I would like to see Level 1 and 2 clinics changed to have an online component which needs to be completed prior to attending a shorter on field/face to face clinic with an instructor. In order to do this, we will need the help of Baseball Saskatchewan to explore options for a website that we can use for the purpose of delivering online content. Perhaps we can somehow use a RAMP website that connects to umpire registration for this purpose. We would like to create online materials for the purpose of rule instruction which would be about 4 hours of time. Communities would still need to apply for and host umpire clinics with gym or field availability for instructors to teach on field mechanics, signals, etc. that would not be effectively learned in an online format. These on field clinics would be about 4 hours in length and could allow for clinicians to do clinics in two nearby communities on the same day or instruct large groups of umpires in smaller sessions to facilitate better learning. This will take some time to first of all explore online options for delivery and creation of materials so a realistic launch of this type of clinic format would be the spring of 2023. I will work with Mike Ramage to explore the online possibilities so we can move ahead.

With all national tournaments being cancelled again this year, it will create further challenges for the selection committee in 2022. If national tournaments are to be played next year, the selection committee will have to consider the umpires that were assigned this year for tournaments next year along with our needs for continued development of our program. There are no guarantees that an official that was assigned to a tournament this year will be assigned to one in 2022. It will be an interesting year in 2022 if Nationals will be played and if travel will return to normal again. I am certain that vaccination status is going to play a role moving forward. We will wait and see what happens on the national stage.

Our Social Media presence has continued to grow and has been very well received! I would like to thank Philip McGee for being the lead on this and developing our social media platform to be the envy of most other provinces in Canada. There are more followers and post engagements every month on our Facebook page. Some of the most popular posts in the past were our National Assignment announcements and our sendoff posts to umpires as they left for their nationals. We are continuing to vary our posts and maintain engagement through the past season.

Saskatchewan continues to take a role in Baseball Canada committees for the further development of umpires in Canada, which also benefits umpires in Saskatchewan. Trevor Drury (Instructor Development), Aaron Roberts (Communications) and Scott Mills (Grassroots) are significant contributors on these national committees and will continue to be involved provincially as well. These committees

produced materials that filter down to the provinces for use by our umpires for training, instruction, etc. Continue the good work gentlemen.

Even though there were no national championships this year, Saskatchewan was still able to hold provincial championships. This year was a challenging year to get provincial championships for a number of reasons:

- With the lower number of umpires registered and the greater than expected number of teams
 participating, it stretched the umpires thin. There were many umpires that had to travel to
 multiple championships to get them covered. There were many championships that did not
 have adequate number of officials and umpires had to work too many games a day. These
 umpires did an admirable job working in difficult conditions.
- 2. There were concerns throughout the process of granting of host sites regarding the number of registered umpires in many of the host sites. There were some host sites that were awarded that had no registered officials. This made the job of the zone directors to assign these tournaments extremely challenging. Umpires were travelling on multiple weekends due to shortages. I discussed the concerns regarding communities not registering umpires earlier in my report.
- 3. Many of the shortages also had to do with the number of tournaments scheduled on the available weekends. Many of the younger umpires that did register were unavailable to work because they were playing or travelling with the family due to a sibling playing. This put strains even in the larger centers that had registered umpires.
- 4. The 15U AAA championship had some challenges. The original weekend was rained out and a back up plan was being considered. I must encourage Baseball Saskatchewan to make decisions regarding rescheduling faster to allow for the rescheduling of umpires. The tournament was cancelled on the Friday of the tournament, but a decision on rescheduling was not made until the following Wednesday for games to be played during the day on the Friday 2 days later. This is not enough time to expect officials to work games and get time off work on a weekday to cover. These decisions need to be made faster. I made my concerns regarding rescheduling locations known on the Saturday after the cancellation and it appeared that my concerns were not heeded at that time for an expedited decision. This led to provincial championship games at a AAA championship on the Friday to be worked with 1 umpire.

I will be continuing to work with educating my zone directors regarding expectations of umpires and number of umpires at provincial championships. We strive to provide quality officiating at all provincial championships and take great pride in a job well done.

Due to all the travel umpires are needing to do for covering provincial championships, I would like to encourage Baseball Saskatchewan to review its current mileage rate of \$.35/km. This mileage rate has been at this amount for as long as I can remember. It is outdated and does not reflect the increases in the cost of fuel, vehicle maintenance, vehicle costs, etc. If we are to expect umpires to travel, they must be compensated for the wear and tear on their vehicles and the cost of fuel. Baseball Saskatchewan's mileage rate is far lower than any other sport in Saskatchewan. Basketball, Volleyball, Football, Lacrosse all pay their officials \$.40/km and Hockey is \$.42/km. An increase in the mileage rate to \$.40/km is overdue. This increase in mileage rate may have a secondary effect in that communities may try to do a

better job of developing local officials so that they will not have to pay mileage to bring in as many officials for league play, tournaments or provincials.

I continued the work of my predecessor with the Co-Commissioners of Baseball Sask in tracking all sanctions reported this year. The number of ejections were down this year which was expected with 1 less month in the season and it was reassuring to see a reduction in the number of games in suspensions decrease over last years alarming number. Of the 46 ejections in this season, there were 14 incidents that required supplementary discipline. Of these 14 incidents, there were 2 warning letters, 2 probations and 31 games in suspensions. There were some challenging incidents in 2021, but we are very pleased with how Baseball Sask supports its officials, and we will continue to work together regarding discipline of players, coaches and umpires. There is still some work to be done in some centers regarding incidents where coaches and fans were abusive or made inappropriate comments towards umpires, followed umpires off the field to both directly and indirectly voice displeasure with an umpire's performance. In centers where this behaviour was more prominent local umpire organizations and minor ball communities with the assistance of zone supervisors will attempt to take steps to deal with these issues and some preventative measures for next season will need to be completed in the offseason such as signage, etc. Some of the issues with game management may be attributed to the lack of face-to-face clinics and the value of training on those areas in a clinic setting. Dealing with player, coach and fan behaviour will be focused on at our clinics in 2022 at levels 1 and 2 when we hope face to face clinics will resume.

I would like to thank Trevor Drury and his guidance and assistance during the past year and I know I will continue to lean on him, along with the rest of the executive to continue to improve the program here in Saskatchewan.

Social Media/Communications:

Social Media Statistics (As of September 30, 2021):

Facebook followers: 495 (421) – YOY growth – 17.6%, (74)

Twitter followers: 141 (139) - YOY growth -1.4% (2)

Comparison Baseball Canadas Umpires: Facebook: 616, Twitter: 434

As evidenced by the statistics our social media presence has increased once again year over year. Information and posts were primarily Facebook based this year. Sending out larger posts can be difficult through Twitter due to its limitations on character counts.

Examples of posts this year were done to recognize members for their on/off field work, notify followers of clinics/events (ie: Golf Tournament), or share rule question videos from Baseball Canada.

Currently the Baseball Saskatchewan Provincial Umpires Committee uses various methods of communication with our members – Social Media, personal email and new this year RAMP. I think it is important that we continue to use these lines of communication with our members so that they are informed.

Policy Manual:

Manual Updates – Changes were made to the operations manual after the March 30th Executive meeting via Zoom. These changes pertained to the Level 3 program and can be found in Policy & Procedure Manual (page 13) available on the Baseball Sask website.

One area of note is that the manual does not make any reference to our program contribution policy. The last thing we have is from 2017 when it was a pilot, and since the pilot we have continued to use it. As a form of housekeeping I feel that it is time that it be formally added to our policy manual and taken out of "Pilot" stage.

Recommendation:

Review the Program Contribution Policy and add it to our formal policy manual.

Registrations/Clinic Attendance:

With Saskatchewan partaking in the online National Clinic for all levels this year and the use of RAMP registration, there was a need to cross verify clinic attendance and RAMP registration. Apart from being time consuming (~10 hours), it was relatively smooth. The names of individuals who did not fulfill the required criteria were submitted to the Provincial Supervisor (Scott Mills). On a couple of occasions, it was an email issue, another time it was a payment issue and for many it was that even with the many dates available many couldn't.

For those that missed online clinics a secondary option was created. With the help of Aaron Roberts, we were able to reuse the Videos of 2020 material and officials complete an online quiz using Google Forms. Once again names were cross verified and submitted to Scott Mills.

Central Document Location

We have continued to use the central Google Drive for document storage. This proved beneficial in storing minutes, old clinic information, education information etc. It has been cleaned up so that stuff aligns with portfolios and years.

Policy Manual/Changes & Notice of Meeting Recommendations:

In 2020 I noted there was no formal method to making changes to our policy manual or notice of meetings. As an executive we spoke briefly on it, but it stalled. I still see a need for coming up with a formal process for change.

Baseball Sask By-Laws

In 2020 I noted that the Baseball Sask By-Laws of the composition of the Umpire Committee do not match how we have been operating. For the 2021 AGM a motion was submitted to reflect how we are operating and one that matched our policy manual.

With the expansion of portfolios within the Committee over the years, a motion was submitted to support the current composition of the Baseball Sask Umpire Division.

- c) Assistant Provincial Supervisor
- d) Up to three (3) members-at-large

Clinics & Registration:

Although our membership suggests 116 members, only about 75 worked games. Of those 75, there were about 2 officials who worked over 80 games. In other words, the workload is will and is beginning to wear down officials. Burnout & quitting will happen if this continues.

Hosting 5 provincial tournaments in 3 weekends was not only very difficult to accomplish in a pandemic year with umpire shortages, but it was proving to add unnecessary costs for hosts – due to finding officials from other zones.

Mentorship program suffered again this year; ~40% 11U games covered, down from nearly 90% pre-covid. Only way for this to change is if we get more officials to work games, creating more time for senior officials to mentor.

Goals for Next Season:

Zone 6 plans to team up with SBCI and the City of Saskatoon to create fan conduct reminder signs at each minor diamond. Matt Schule declines reelection for this year and Aaron Szejvolt was elected by Zone 6. I would recommend to the next Zone 6 executive to consider cheap/free ways to advertise.

Discipline / Game Management concerns / Hotspots:

Fan conduct at 15u and younger was increasingly poor and some umpire conduct needed to be addressed. Overall conduct expectations need to be addressed in next upcoming clinics. Communication skills specifically in game management needs to improve for some officials who are beginning to work higher levels of ball.

Umpire reporting training needs to happen. There were incidents of poorly completed reports as well examples of over exaggerations that could lead to substantial consequences.

Recommendations for P.U.C. / Executive Committee:

I would like to suggest directors try to find 1 additional person to be a member at large. We seem to have a small group and to get more ideas, involvement and possible delegation of certain tasks, there is potential for growth. Not every zone has the luxury of 'easy-to-find' replacements.




